



One of the most important debates to come out of the growing foreign-born

population in the United States is the issue of sanctuary cities. **Figure 1** records the number of both undocumented and documented immigrants throughout American history. Sanctuary cities provide refuges for immigrants by refusing to work with immigration authorities such as ICE. The debate has centered around the issue of federalism.

Immigration and Crime



There is a common belief that immigrants commit more crimes than native born citizens. In reality immigrant commit less crimes than their native-born counterparts and actually reduce the crime rate in cities. Figure 2 to the left shows immigrants actually decrease the crime rate in communities because they are less likely to commit a crime than native-born Americans. It is

dangerous for foreign-born immigrants, especially undocumented foreign-born immigrants, to commit crimes because they could be sent back to their country of origin.

Immigration and the Economy

Immigrants are economic boons to cities because they create many jobs for both native-born and foreign-born Americans and have little impact on American wages and job prospects. 51% of billion-dollar startups are created by immigrants. ⁷ Immigrants found more billion-dollar **51%** of all billion dollar startups than native-born citizens, even though startups are founded by immigrants make-up less of the total population of the immigrants United States. They create jobs for hard-working American families. It has also been found that there is no statistically significant impact of immigration on the wages and job prospects of native-born citizens. Taken together, these two facts show that immigrants are job creators instead of job stealers.
